## CONDITIONS

### THESE CONDITIONS APPLY TO ALL CANDIDATES WHO SIT THIS EXAM.

- ◆ Applications to sit this exam should be received no later than 26<sup>th</sup> July 2010. Applications received after this date will be subject to a \$10 late fee.
- ◆ You must sign and date this application form, certifying that you have read and will abide by the terms and conditions of the FAA Exam Booklet. This Booklet can be obtained free from the FAA web-site (<http://www.faainc.org.au/Exams/faaexam.htm>) or in hard copy from the Director at a cost of \$25.00.
- ◆ The cost of the exam is \$130.00, payable upon application. The attached application form should be signed and sent to the FAA Inc. Board of Examiners, 50A Cowper St, Byron Bay, NSW, 2481.
- ◆ This exam comprises three sections. The overall pass mark for this exam is 60%. Candidates must also achieve a minimum mark of all sections (1, 2 & 3) of the Exam in order to gain an overall pass (see Exam Book for more information).

The venue for each State will be advised to candidates prior to the exam date. This is an open book exam. You may bring in any material, other than a computer or PDA (palm computer) to refer to during the exam. Scientific Calculators are acceptable.

Mobile phones **must be turned off** for the duration of the exam.

- ◆ Your name must NOT appear on any of the examination papers that are submitted. You will be issued with a Student Number by the Director. This number is to be written on all submitted on each page of assessment papers to ensure the anonymity of each candidate.
- ◆ All material submitted will become the property of the FAA. Copyright of all material remains with the author.
- ◆ Examination papers may be retained by candidates at the conclusion of the exam. Candidates are given the option of paying a \$20 fee to enable their "Answer Sheet" to be copied and returned after marking. A time limit of 30 days after receipt of marks is allowed for request of papers. The return of papers is not a review or included in the Review fee.
- ◆ All candidates must be current financial members of an FAA affiliated organisation.
- ◆ The Board of Examiner's decision with respect to results is final.
- ◆ These conditions form part of the Application for this Exam.

#### WITHDRAWALS AND CANCELLATIONS:

Cancellations received seven (7) days prior to the Exam being mailed out to Supervisors, will incur a \$20 withdrawal fee. The Application Fee, minus the \$20 withdrawal fee will be reimbursed within seven days of receipt of written notice of withdrawal.

If you withdraw from the exam once the exam papers have been despatched to Exam Supervisors, all monies paid will be forfeited. (Please advise the Examination Board Director asap if you are withdrawing.)
